Spotlight on Colorado

Southwest Colorado: a hidden gem and conservation legacy

There is a special mystique about southwest Colorado. It is a hidden gem that can be enjoyed from the scenic vistas in the San Juan Mountains to the working farms and ranches below. This part of the State should be explored and is an important part of our ranching and conservation legacy. In this "Spotlight on Colorado" we will explore many of the counties in this region of the State and our success in protecting forever the ranching landscapes of these special places.

If you have never visited Southwest Colorado, then we encourage you to drive down one of the seven scenic and historic byways through the region. If you take one of these drives in the fall, you will see that the aspens produce some of the most brilliant fall colors in the country. You will be amazed by the sheer variance of topography from the depths of the Black Canyon of the Gunnison National Monument to the exhilarating vistas from Grand Mesa, the world's largest flattop mountain. This region is also rich in western history and Native American cultures.

During your visit to this spectacular part of the state, you will see many working ranches and thousands of acres of beautiful and protected land. CCALT has been busy in Southwest Colorado and is proud to have protected over 45,800 acres of working agricultural lands to date. Our project staff has ongoing projects in this region and will be able to preserve several more ranches before the end of the year.

Spotlight on Colorado continued

Approximately half of the 45,800 acres in Southwest Colorado that CCALT has protected can be found in Archuleta County. Known primarily for Pagosa Springs and its hot mineral baths, it is surrounded by the San Juan National Forest and the spectacular Weminuche and

South San Juan Wilderness areas. Our conservation work is supplemented by these already-preserved wilderness areas, especially near Chromo and along the Upper Piedra River.

In Gunnison County, 17 ranching families came to CCALT and the Gunnison Ranchland Conservation Legacy (GRCL) to protect their land and place their ranches under conservation easement. Helped along in the 1990's by a



multi-year, multi-million dollar commitment of Colorado lottery funds through a Great Outdoors Colorado Legacy Grant, these families were able to preserve these valuable working landscapes for future generations. As a result, over 15 miles of Tomichi Creek along U.S. Highway 50 have been protected.

Two counties that offer rivers, mountains, valleys, orchards, vineyards and more are Delta and Montrose Counties. This diverse region has not only a lot to offer, but is also a tourist's dream. Surrounded by fields, orchards, national forests and other working lands; the drive to Grand Junction and to the Grand Mesa could not be more enjoyable. Many landowners wanting to preserve their heritage have worked with CCALT to allow them to keep their ranch in the family and out of development.

Lastly, but certainly not the least important, are San Miguel and Ouray Counties which provide some of the most spectacular landscapes that you will ever see. Best known for the towns of Telluride, Ouray and Ridgway, this region is arguably one of the hidden jewels in the State. CCALT is lucky to have partnered with the San Miguel County Purchase of Development Rights program and their commitment to ranchland protection. Home to some of CCALT's original easements, this part of the State has a place close to our heart.

We welcome all of you to take the drive through scenic Southwest Colorado. Enjoy the lands that we have protected with your support, and say a special thanks to those landowners who have chosen to protect the land that we love.

Leaving a legacy for future generations

Estate planning is a very important step and your decision should be made carefully. Whether you are a concerned rancher or just dedicated to conserving land in Colorado, CCALT hopes that you will keep us in mind while planning for your estate.

Include CCALT in Your Will – Charitable Bequests

Charitable bequests are a common method of giving where an individual can name the Colorado Cattlemen's Agricultural Land Trust, or any other charity, as the heir to a portion of his or her estate. Making a bequest allows you to make a significant contribution toward protecting Colorado's working farms and ranches for future generations.

Including us in your will or trust gives you the maximum flexibility to continue to use your assets during your lifetime. You can make us the beneficiary of your retirement plan, life insurance plans, bank account, brokerage account, or real estate.

If you plan to make a gift through your will, the language to the right is just one example of what you can use and may be useful to you during your estate planning.

Conservation Easements in Estate Planning

Conservation easements can also be a powerful estate planning tool that may result in significant estate tax savings. Just as every farm or ranch is unique, every family's situation requires special attention. CCALT will work with landowners who are interested in seeing if conservation easements or other options can be a part of a CCALT Wish List larger estate plan.
